

REF. PRELIMINARY INJUNCTION ISSUED AGAINST TILTEX MANUFACTURER, EUROBENT SP. Z O.O. FOR INFRINGEMENT OF CONCRETE CANVAS PATENT.

A Polish court has issued an **interim injunction** against Eurobent Sp. z o.o, the manufacturer of Tiltex, to refrain from infringement of Concrete Canvas Technology Ltd.'s patent PL/EP 2027319 – the decision to secure the claim of the entitled party was made by prohibition obliged party to manufacture, import, offer or placing on the market products possessing characteristics covered by patent protection. This decision was upheld by appeal court.

Interim injunction is a temporary order given by a court of law until an official decision in the case can be made. It does not determine the essence of the case but only states if the legal procedure has been kept by the first instance court.

Eurobent would like to declare that there is no patent infringement since TILTEX is manufactured in a full compliance with the US 4495235 patent, which is in a free domain since 2005 and was a part of the state of the art at the time the applicant obtained the PL/EP 2027319 patent.

Respecting the court decision Eurobent has stopped all commercial activities related to contested product, nevertheless spreading unsubstantiated information about the company with 10 years of experience in geosynthetic market cannot be allowed.

Concrete Canvas Technology Ltd.'s is aware of the TILTEX production method and the reason of the court case is obviously the need of disposing of a competitor.
